Contractee is responsible for any damage caused to a contracted vehicle by themselves or parties he/she allows in the vehicle. **NO DRUGS, ALCOHOL OR SMOKING** will be allowed in any contracted vehicle. If you spill any kind of fluid, food or vomit in the vehicle you will be charged a \$150.00 sanitation charge. We provide you with ice, sodas and non-alcoholic champagne for your convenience. Standing through the sunroof, hanging out of windows or throwing debris from the vehicle is strictly prohibited! Tru Limousine, LLC is not responsible for any items left in the vehicles.
